Alderman Williams made the motion to terminate employee #1552, effective immediately, based on the recommendation of the City Clerk and to include pertinent information regarding the matter in the individual's personnel file, seconded by Alderman Vinson and upon unanimous vote the motion carried.

Alderman Farris made the motion to terminate employee #2180 based on the recommendation of the City Clerk and Police Chief and to include pertinent information regarding the regarding the matter in the individual's personnel file, seconded by Alderman Coker and upon the unanimous vote the motion carried.

Alderman Craine made the motion to resume the Regular Board Meeting out of Executive Session, seconded by Alderman Coker and upon unanimous vote the motion carried.
